PURPOSE

The purpose of this Climate policy is to define and reflect our commitment to taking meaningful and sustainable actions to address climate change and related environmental issues associated with our business. OUR POSITION & REQUIREMENTS

According to NASA, there is "unequivocable evidence that Earth is warming at an unprecedented rate, with human activity as the principal cause". Additionally, the United Nation's Intergovernmental Panel on Climate Change (IPCC) states, "Since systematic scientific assessments began in the 1970s, the influence of human activity on the warming of the climate system has evolved from theory to established fact." As such we acknowledge that climate change is real, and we are committed to mitigating the risks and impacts associated with it, while better managing the environmental impact of our operations.

Consistent with our core values, we expect all employees to understand and make decisions that support our climate goals and sustainability commitments. In addition, we will also endeavor to do business with companies, including those third parties involved in our supply chain, that share in this responsibility to mitigate their climate risks and environmental impacts.
